## The Lane County Republican Office is opening



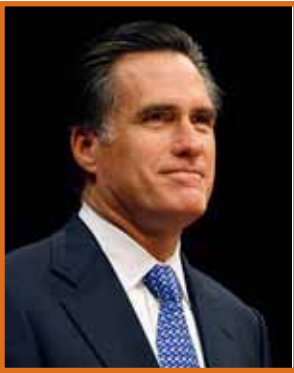

## MITT ROMNEY
